

RAPID RESPONSE: HOW SARASOTA COUNTY ACCELERATED DISASTER RECOVERY AFTER HURRICANE IAN



THE CHALLENGE

In September 2022, Hurricane Ian devastated Sarasota County, leaving thousands of residents in urgent need of assistance. Early efforts to implement recovery programs faced challenges due to a previously adopted technical solution that did not fully meet the county's complex requirements. Recognizing the need for a more robust and flexible platform, Sarasota County's newly created Resilient SRQ Office partnered with Neighborly Software to swiftly configure a solution and migrate existing applications to the new system. The goal was to deploy \$201.5 million in CDBG-DR funds across multiple recovery programs while ensuring strict compliance with federal regulations.

Given the urgency and scale of recovery, the programs were launched in phases based on a critical-path approach. The practices, workflow templates, and flexible configuration tools enabled the county to rapidly deploy the Housing Recovery program in three weeks from the kickoff meeting.

Two months later, the Infrastructure and Public Facilities program was rolled out to address the county's infrastructure recovery needs and support the development of affordable housing for displaced residents.

RESULTS

In the first six months of using Neighborly Software, Sarasota County achieved impressive outcomes by focusing on speed, compliance, and efficiency:

- applications from the prior system.
- ✓ Conditionally approved \$40M in affordable housing development to 8 projects.

Onboarded and trained 40 administrators and third-party service contractors.

- Allocated \$70M across 13 public infrastructure projects.
